TEDBURN ST MARY PARISH COUNCIL CEMETERY CHARGES & RULES 2023-2024

As approved by the above Council at their meeting on the 4th April 2022, the Rules and Fees stated below come into force on the 7th April, 2022 in accordance with the provisions of the Local Government Act 1972. To be reviewed March each year.

Qualification

The person to be interred, or in respect of whom the exclusive right is granted, must be, or have been an inhabitant of the civil Parish of Tedburn St Mary or, in the case of a still-born child, the parents (or one of them) must be, or have been, such an inhabitant.

Fees

- The Fees are separated into three sections dealing with the plots (burial and cremated remains), interments and the memorials
- All charges contribute towards the ongoing cost of administration and maintenance of the cemetery.
- Charges will be applied in all cases, booked in advance or not.

For the exclusive right of burial in an earthen grave 9' x 4' in perpetuity

Grave

SINGLE depth.	£368.00
For the exclusive right of burial in an earthen grave 9' x 4' in perpetuity DOUBLE depth.	£523.00
Cremated Remains Area	
For the exclusive right of burial in an area not to exceed 15" x 15" SINGLE depth	£167.00
For the exclusive right of burial in an area not to exceed 15" x 15" DOUBLE depth	£213.00

(Please note that when Exclusive Right of Burial/Cremated Remains is purchased, in advance or at the time of interment, the Parish Council reserves the right to allocate the plot number).

Interment Charges

For Interments in a Grave

body of a still-born child, or a child whose age at the time of death did not exceed one month.

£45.00

body of a child whose age at the time of death exceeded one month but did not exceed 12 years.

£115.00

of the body of a person whose age at the time of death exceeded 12 years.

£210.00

For Interments in a Cremated Remains Plot

in an area not to exceed 15" x 15"

£95.00

Monuments - gravestones, tablets and inscriptions

Please note that the kerbstones, trees, shrubs, plants or any obstruction that might prevent the maintenance of the cemetery are not permitted in or around any Grave/Cremated Remains Plot.

For the right to erect or place on a grave:

A headstone not to exceed 4' in height, 12" in depth, 2'6" wide with a foundation base of 3'

£232.00

A vase not to exceed 12" x 12" x 12"

£63.00

Vases must be placed at the head of the grave space, or where headstones are in position, immediately in front of it.

A horizontal tablet, not to exceed 18" x 18" on any grave

£69.00

For the right to place on a cremated remains plot:

a flat slab not to exceed 14" x 14" x 2"

£75.00

Cremation Tablets must be bedded into the ground level with the surrounding soil.

Additional inscriptions on any memorial

£58.00

If a search of register books is requested there will be a charge of £45.00 and a charge of £10.00 for a certified copy of entry of burial in the register
